We are confident that each participant will have an educational and fulfilling experience; however, we reserve the right to send home any camper who does not follow the rules.

Drop-off

Sign-in starts at 8:00 am each day. For safety reasons, YOU MUST SIGN YOUR CHILD IN & OUT EACH DAY WITH A PHOTO ID. Parents must sign in/out campers, even if the camper is old enough to drive themselves.

Pick-up

All campers need to be picked up at 12:00 pm, unless you have registered for post care. If you are later than 12:00 pm, there will be a charge for \$1 per minute. For the safety of your children, campers will only be allowed to leave with those persons you have authorized on your registration form. Photo ID will be required at sign-out.

Lunch, Snacks & Water

There is no refrigeration available so please pack additional snacks, if needed, accordingly. We will have water bottled water and small snacks. Campers are reminded to drink plenty of water during the day so they do not become dehydrated!

To Wear/Bring

The following is a list of things campers should wear and/or bring in a backpack:

**Life Jacket- (mandatory safety precaution) we will be in 1-4 feet of water on some days.

*Sunglasses

*Swimsuit

*Sunscreen

*Towel

*Water shoes

*Exposure shirt

*Gloves on the last day
